- (2) The above amounts exclude wagering activity at the Foxwoods and Mohegan Sun casinos which operate under the auspices of the federal Indian Gaming Regulatory Act.
- (3) Connecticut Jai Alai, Inc. (Milford Jai Alai) ceased operations December 12, 2001.
- (4) Plainfield Greyhound Park ceased live racing on May 14, 2005.
- (5) Shoreline Star Greyhound Park ceased live racing on October 10, 2005 and was acquired by Autotote Enterprises on April 5, 2006. Autotote Enterprises decided not to run live racing.
